- **NEW! L&H Agents Selling Medicare Products Only:** Offers a base rate of \$374 for limits of \$1,000,000/\$1,000,000
- **Newly Licensed L&H Agents Selling P&C:** Offers a base rate of \$670 for limits of \$1,000,000/\$1,000,000
- **Standard L&H Agents Selling P&C:** Offers a base rate of \$765 for limits of \$1,000,000/\$1,000,000
- **Standard P&C Agents:** Offers a base rate of \$680 for limits of \$1,000,000/\$1,000,000
- Provides coverage to the agent as an insured at a single bundled rate based on the limits the agent selects
- Expands coverage to an agency entity only for the acts of an insured agent
- Provides coverage for administrative, clerical, and support personnel while they are acting on behalf of an insured agent – Non-producing
- Your owned or controlled business entity is covered so long as the alleged wrongful act arises out of your Professional Services. If you have more than one agent doing business on behalf of an agency, you may want to consider purchasing Agency E&O.
- L&H Agents: Underwritten by CNA Insurance Company (an admitted carrier rated A by A.M. Best)
- L&H Agents Selling P&C and P&C Agents: Underwritten by National Casualty Company (an admitted carrier rated A+ XV by A.M. Best)

Agency Policy

- **P&C Agencies:** Offers a base rate of \$980 for limits of \$1,000,000/\$1,000,000
 - Additional coverage options to include commercial lines, life, health, annuities and mutual fund sales
- **L&H Agencies:** Offers a base rate of \$1,530 for limits of \$1,000,000/\$1,000,000
 - Additional coverage options available to include sale of P&C
- Exclusively for retail agencies as the named insured
- Policy is designed to afford coverage to the agency, owner(s), employees, and independent contracted agents while acting on behalf of the agency only
- Additional coverage limits & income tier pricing are available
- Underwritten by National Casualty Company, an admitted carrier (an admitted carrier rated A+ XV by A.M. Best)
